Conditions of the Sale

I understand that my participation in the Louisville Skating Academy (“LSA”) Figure Skating Equipment & Apparel Sale (the “Sale”) is voluntary. I understand that a 30% commission will be deducted from the proceeds of any item sold at the Sale to benefit the General Fund of LSA. I acknowledge and understand that my proceeds, net the 30% commission will be paid by check and will be mailed to me in the self addressed stamped envelope that I provide to the Louisville Skating Academy. Checks will be mailed within 6 weeks after the Sale date. I agree to pick up my unsold items at Iceland within 7 days of the last day of the sale. I agree that if my items are not picked up that they become the property of Louisville Skating Academy (“LSA”).

By checking this box I choose to have my unsold items be removed from Iceland and stored at the home of Carrie Forshner (co-Chairperson of the Used Equipment Sale) until the next equipment sale. I understand that my participation in Take Home Program is voluntary. My items remain my property. My items will then be returned to Iceland and be included in the next Used Equipment Sale (“Sale”). I agree that my items will be sold at the prices they are currently marked unless I provide new tags for them before the beginning of the new Sale. This waiver only allows my items to be stored for the time period after the immediate Sale until the next Sale. I agree that my items will be included in the next Sale and it is my responsibility to provide a new waiver and self addressed stamped envelope for the next Sale. I can obtain my items at anytime by providing the co-chairperson five (5) days notice to bring my items to Iceland for retrieval. Once they are retrieved by me they cannot be re-stored.
